Minutes of an extraordinary meeting of '**Blakeney Parish Council**' which was held on **Tuesday 11<sup>th</sup> August 2015** in the Parish Office commencing at 7pm.

1. **Apologies for Absence** – Were received and ***accepted*** from; Barry Girling (*work*) & Alban Donohoe (*work*).

2. **Declarations of Interest** from members. None received.

3. It was ***proposed & agreed*** that the following **Minutes** are signed as a true record;

4. *To receive & consider* the following **Planning** Applications:-

4.1. Application No. **PF/15/1000** – *Proposal; Erection of extension to front and side of dwelling following demolition of garage (revised scheme 15/0210 refers) at, **Blakeney Downs House, Morston Road, Blakeney.** It was ***proposed & agreed*** that we have no objection.*

4.2. Application No. **PF/15/1071 & LA/15/1072** – *Proposal; Erection of two storey extension to side of dwelling and boat store extension to annexe at, **50 High Street, Blakeney.** It was ***proposed & agreed*** that we have no objection.*

5. It was ***proposed & agreed*** that **Accounts** to date totalling £15,659.49 are paid.

6. **Clerk/RFO Report** showing the current finance position was shared with members.

7. It was ***proposed & agreed*** that we permit the **Blakeney Beavers** to site 2 large tractor tyres close to the Scout Hut for gardening purposes and that we will monitor the situation. Neil Thompson happy to donate 2 tyres should they need them.

8. It was ***proposed & agreed*** that we utilise the **Former School Field** for parking throughout the duration of the Gray's Funfair visit to The Carnser. The Clerk had set out a list of items to be addressed and the members were happy with the recommendations, which included that the car park would be pay & display, £3 per vehicle, manned from 10am to 5pm, all cars to be moved by 7pm and gates locked shortly afterwards etc.

9. Members were advised that the due start date for the installation of the planned **BMX Track** (3<sup>rd</sup> August 2015) was not able to be met by DT Leisure, due to his wife having suffered a major stroke just days before. It was ***proposed & agreed*** that we hold on in the hope that he can install this for us by Spring 2016 at the latest, and if need be, that we reconsider then. We note that our current funding means that we are short by £6,073 and that whilst we note that the Clerk will apply for further funding we are happy to make up the difference from our reserves. Whilst the 2016 fireworks income was suggested, we would like this to be added to the 2016 Community Fund.
